Juniper has been working on Strategic Planning, DEAI work, the annual report, and hiring. She is also focused on recuperating life work balance and encouraging staff to do the same.

Harwood is almost fully staffed.

The Store & Experience Manager position has been filled by Katy Ballard.

In the final stages of Development & Marketing Manager position.

Have hired 3 teaching artists and looking for one more artist out of Peñasco

We were awarded the NEA grant for EASLE

- Additional funding provide by FIN (with HED approval) for HVAC and Boiler replacement. Thanks to Teresa
- Luce Foundation-Their grants director, Terry Corbone will be in NM and is going to do a site visit mid October.

The Harwood 100 More - 3 days of events to engage the community

We had our first two-year out Long-Range Exhibition meeting for internal cross-departmental planning. We have been working towards this for over a year, so a success to finally get there.

Challenges:

Since the Dutton exhibition, we have been struggling to maintain the humidity due to certain loans. Because of that we have some mold growth. We have had it tested and began mitigation. Contractors are not available until January. For the near future we are not taking on loans that

require that level of the humidity. It may take a 6-week time frame to close the galleries upstairs to complete the proposed work. Susie has been in touch with UNM Risk Management UNM and Environmental Health and Safety regarding this issue.

Deinstallation- for the entire museum is difficult. We are considering closing the museum to the public for 3 weeks after Centennial (January 31) and before Raven Chacon opening (Feb 23).

Discussion of closure, environmental concerns, and cost. Teresa shared some experiences with other UNM properties and also reached out to UNM leaders for support and guidance.

Juniper is working on requesting space planning with UNM Provost office.

Attendance is back up to pre-pandemic levels!

Harwood Associate Spotlight Collections Associate Stephanie Stewart is the newest staff member and is working with Chris in Collections. She has an Associate's from IAIA and a Bachelor's in museum conservation from NMSU.

Has worked at IAIA museum for about 7 years. Recently finished a Smithsonian Internship. Education Presentation by Christina Neubrand on *Voice and Choice*. it has gotten more difficult this year to visit by to visit the schools due to staffing changes, so we invite students to the education space.

Looking to do more residencies at schools with the EASLE grant this school year.

Strategic Plan Update - by Eduardo Martinez

Both the board and staff retreat have been completed. Working on completing documentation of the information and conducting focus groups August 30th- Hispanic Latino community, in September with
